

## IPM Training Report

Country: Tanzania

Date of training: 14 to 17 December 2009

Place: Mgoro-goro Tanzania

### **1. Description of activities:**

The training program was the full CropLife IPM Training course including an evening class refresher on how to train people as well as a responsible use session (Pesticides from Shop to Field)

### **2. Participants:**

A total of 10 participants (6 male and 4 female) attended the program. It was a mix of participants consisting of commercial trainers and CNFA personnel

### **3. Program feedback:**

The knowledge of the participants was evaluated with a pre and post test as well as an assignment consisting of 2 compulsory questions and 2 questions where participants had to complete 1. The assignment was to test if participants will be able to apply knowledge learned in the field. All 14 participants received certificates of competence.

The improvement of knowledge by the participants from the first day to the last day was far above average

- What problems need to be addressed in Tanzania in terms of small farmers and agro input dealers?
- What can we do about these problems?
- How do we need to do this?

The participants submitted their action plans for training in 2010 at the end of the training. These commitments will be driven by CNFA in 2010.

- IPM refresher
- Technical training – Agricultural inputs
- Responsible use of pesticides
- Best practices for farmers
