## ACTIONS REQUIRED

- Provide proposal for future training for discussions at North Africa Middle East hub meeting in Beirut, in October. To include Training of Trainers program for target audiences - extensionists, industry engineers, retailers/distributors, schools, custom sprayers, farmers, farm workers, medical personnel (ASPLANTE).
- Consider media program to publicise safe use (ASPLANTE).
- Provide all available school safe use training materials (PM).
- Contact Ministry of Education regarding incorporating training on safe use in school curriculum (ASPLANTE).

- Try out on-farm incinerator and discuss with appropriate Ministries - Health, Agriculture, Environment (ASPLANTE).
- Follow up on training implementation - incinerator, disposal pits (ASPLANTE).
- Provide details of previous and current stakeholder co-operation for Crop Life International training and other pesticide related projects, to pass on to ASPLANTE for future training co-operation (AMA).
- Provide training materials to all institutes visited (ASPLANTE).
- Collect IPM success stories for CropLife Africa Middle East (ASPLANTE).
- Collaborate with various projects on implementing demonstration sites (ASPLANTE).
- Send Permaculture materials to Aljawad (PM).
- Send Natural Remedies book to Aljawad (PM).
- Get CropLife Egypt dealers training materials from them (ASPLANTE).

## **CONCLUSION**

Another extremely busy, useful and relatively productive visit for me. There is still a great need to devise methods to get operators to use PPE, and farmers to clean, destroy and dispose used pesticide containers.

Selection of personnel to attend future Training of Trainers course now necessary.
