## ACTIONS REQUIRED

- Contact other potential stakeholders regarding possible co-operation in future training (CropLife Ethiopia, LH).
- Each participant is to set out his plans for the coming 6 months, which must include at least one, preferably two, trainings per participant, including submitting a training plan to Olivier & Getachew by end of December (GC, OM).

## CONCLUSION

Another successful ToT course. Some participants struggled. Two became sick, and so have not completed the course. For them to complete they must now write the test and redo their lessons. This is to be arranged by Getachew and Olivier. Two participants received Certificates of Attendance. Ten participants received Certificates of Competence. The two who received Attendance Certificates will be allowed to rewrite the test and redo their lessons, to try and upgrade their certificates to Competence. Again for this to be arranged with Getachew and Olivier.

It is very critical for Getachew to follow-up on the training plans, to be submitted by end of December, and also to follow-up on each participant doing further training. All trainings must be reported to the Obstocks Project Team, CropLife Ethiopia and CropLife Africa Middle East.

Discussions with Kevin Helps also included the updating of the Disposal Guideline. He would like to meet with our editorial people and discuss the content. An important issue for CropLife International, which I will follow up with Keith.

I cannot thank Olivier Machiels of Belgium Technical Cooperation, enough for all his efforts and co-operation in putting together this ToT course, with such limited funds. Getachew too, must be congratulated on his efforts and hard work. Many thanks.
